What does MS4 mean?

Happy New Year from the Goshen Stormwater Department and welcome to all the new City employees. Let's being 2017 with a stormwater refresher, by explaining why the City of Goshen is considered a Municipal Separate Storm Sewer System or MS4. An MS4 is defined by the Indiana Department of Environmental Management (IDEM) as "a conveyance or a system of conveyances owned by a state, city, town, or other public entity that discharges to waters of the United States and is designed or used for collecting or conveying storm water." But, the term

MS4 does not solely refer to municipally-owned storm sewer systems, but rather is a term with a much broader application that can include, in addition to local jurisdictions, state departments of transportation, universities, local sewer districts, hospitals, military bases, and prisons. An MS4 is not always just a system of underground pipes; it can include roads with drainage systems, gutters, and ditches.

In Indiana, MS4s are cities and urbanized areas with a population density of 10,000 or more, but less than 100,000 and must meet the requirements of Rule 13 (327 IAC 15-13). The requirements include six minimum control measures (MCMs). Help Keep Street Drains Flowing

Storm drains cannot function properly when their grates are clogged with leaves, ice, and snow. A blocked drain can lead to flooding and other safety issues like ice. If you have a storm drain near your home or business, please clear away any debris, ice, or snow from the catch basin grates. The City appreciates your help in keeping the storm sewer system working.

If a storm drain still does not drain, contact the Stormwater Department at 574-534-2201 and we will send someone to help.



Report an Illicit Discharge

An illicit discharge is anything other than rain that could flow or be washed into a storm drain.
