The Common Council of the City of Goshen, Indiana met in a regular meeting on February 7, 2017 at 7:00 P.M. in the City Court Room/Council Chambers at the Goshen Police & Court Building, 111 East Jefferson Street, Goshen, IN. CHANGES TO THE AGENDA
