GOSHEN COMMON COUNCIL

Minutes for the Regular Meeting of April 11, 2017

The Common Council of the City of Goshen, Indiana met in a regular meeting on April 11, 2017 at 7:00 P.M. in the City Court Room/Council Chambers at the Goshen Police & Court Building, 111 East Jefferson Street, Goshen, IN. Presiding Officer was Mayor Stutsman, with members of the Council present or absent as follows:

CHANGES TO THE AGENDA

Mayor Stutsman informed the council that Mark Dobson of EDC of Elkhart County was unable to present at the meeting. Mayor Stutsman also requested that Privilege of the Floor for the public be held after the presentation for Vibrant Communities. Motion to approve changed made by Councilwoman King. Motion seconded by Council President McKee. Seeing no other changes to the agenda, Mayor Stutsman called for a vote to approve the Agenda as amended.

By a 6-1 vote the motion passed.

PRESENTATIONS

Diana Lawson of the Elkhart County Convention of Visitors Bureau opened the presentation for the Vibrant Communities project at 8 minutes and 08 seconds of the audio recording. Also speaking were Arvis Dawson and Suzie Weirich. Council questions regarding the presentation begin at 12 minutes and 58 seconds of the audio recording. There were no public comments.

APPROVAL OF MINUTES

Mayor Stutsman called for a motion regarding the Minutes from March 21, 2017. Motion made by Councilwoman Gautsche to amend the Minutes regarding Ordinance #4897 Section 14 to reflect that the second motion within Section 14 is to Item C instead of Item A. Motion seconded by Councilwoman King.

By a 7-0 unanimous vote the motion passed.

Mayor Stutsman called for a motion to approve the Minutes as amended. Motion made by Councilwoman Gautsche. Motion seconded by Councilwoman King.

By a 7-0 unanimous vote the motion passed.

PUBLIC HEARING

Mayor Stutsman opened the Public Hearing for the Community Development Block Grant Annual Action Plan Program Year 2017.

City Planner Rhonda Yoder spoke at 20 minutes and 41 seconds of the audio recording. There were no public comments.

Mayor Stutsman closed the Public Hearing.

After the discussion, the meeting shall be cancelled if the Mayor, Council President, and the annual designee all agree. The Presiding Officer has the authority to cancel a Common Council meeting in case of severe weather or other emergency circumstance." made by Councilman Scharf, Motion seconded by Councilwoman King.

Mayor Stutsman asked the Clerk-Treasurer to call the roll. Roll Call was as follows:

By a 4-3 vote the motion passed.

Mayor Stutsman asked the Clerk-Treasurer to call the roll. Roll Call was as follows:

By a 4-3 vote the Ordinance passed.

ORDINANCE #4898

Council President McKee introduced Ordinance #4898 entitled "GOSHEN ZONING ORDINANCE TAX AMENDMENT."

Council President McKee asked the Clerk-Treasurer to read the Ordinance by title only for its first reading and moved for its passage. Motion seconded by Councilwoman Gautsche.
