**REQUEST TO APPROVE INFRASTRUCTURE AND MAINTENANCE BOND—
WAVERLY AVENUE SEWER EXTENSION JN: 2009-0030**

Director of Public Works Dustin Sailor requested Board approval for the Waverly Avenue Sanitary Sewer Extension West of the Goshen Millrace Canal. The installation of infrastructure (force main) has been satisfactorily completed for the above listed project. The Engineering Department recommends that the infrastructure be accepted for maintenance. The three-year maintenance bond (10% of the construction costs) for the infrastructure has been submitted to the City of Goshen Engineering Department.

Board Member Landis moved to approve the request. Second by Board Member Day and motion passed unanimously.

**REQUEST TO APPROVE INFRASTRUCTURE AND MAINTENANCE BOND—
DICKERSON LANDING PHASE V JN: 2014-0046**

Director of Public Works Dustin Sailor requested Board approval for the Dickerson Landing Phase V project. The installation of infrastructure (sanitary and storm sewer, water main, curb, sidewalk, and asphalt) has been satisfactorily completed for the above listed project. The Engineering Department recommends that the infrastructure be accepted for maintenance. The three-year maintenance bond (10% of the construction costs) for the infrastructure has been submitted to the City of Goshen Engineering Department.

Board Member Day moved to approve the request. Second by Board Member Landis and motion passed unanimously.

REQUEST TO APPROVE NO PARKING SIGN INSTALLATION

Director of Public Works Dustin Sailor requested Board approval to install "No Parking" signs on the east side of Industrial Park Drive. A business owner is having semis block his driveway

while they wait to use the loading docks. The Street Department will determine the locations needed. This request was approved by the Traffic Commission.

Board Member Landis moved to approve the request. Second by Board Member Day and motion passed unanimously.


There being no further business Mayor Stutsman moved to process claims and then to adjourn. Second by Board Member Landis and motion passed unanimously.


