Each licensed electrical, mechanical, and plumbing contractor **is required** to obtain a separate permit for the respective work to the new residential building or structure, but there will be no additional permit fees charge for the separate permits. (Fee Ordinance 4899 Sec. 2.01(A)(1))

Remodeling/Renovation \$ 83.00

The residential remodeling permit does **not** include the individual permits, fees, and inspections related to mechanical work, plumbing work, electrical work, water heater installation, and gas line installation and connection (Fee Ordinance 4899, Sec. 2.01(B))

Accessory (Detached Garage, Shed, Deck, Pavilion/Gazebo) \$ 83.00

The accessory residential permit does not include the individual permits, fees, and inspections related to mechanical work, plumbing work, electrical work, water heater installation, and gas line installation and connection (Fee Ordinance 4899, Sec. 2.01(C))

Window (any size) \$ 57.00

Siding (including masonry) \$ 57.00

Roofing (including all roofing systems & decking) \$ 57.00

Swimming Pool \$ 57.00

Demolition (regardless of size or type of structure) \$ 29.00

COMMERCIAL BUILDING PERMIT FEES

Foundation \$282.00

This permit is included...unless the foundation permit is separately submitted for approval so that the foundation can be construction prior to the issuance of a building permit..." (Fee Ordinance 4919 4.01.)

Remodeling/Renovation**\$ 304.00**

The commercial remodeling permit does **not** include the individual permits, fees, and inspections related to mechanical work, plumbing work, electrical work, water heater installation, and gas line installation and connection (Fee Ordinance 4899, Sec. 2,01(B)). Commercial projects require all plumbing, electrical and HVAC (mechanical) work to be performed by licensed contractors.
