Call to Order & Opening

Roll Call and introduction of visitors:

Review of the CRC Mission and Principles: Read aloud by the group

Introduction of CRC members and visitors -: Kyle Richardson, Goshen resident, and Heather Bridger-Ulloa, 1107 S 7th Street, Goshen resident.

Review the agenda: AJ added the following documents to the "New Business" line; Annual Report, Sreekala Rajagopalan and Michele Fanfair-Steury thank you letter. Motion: To amend the Agenda, for documents to be added to the "New Business" line.

Motion by: Glenn Null **Passed unanimously**.

Review Minutes: January 10, 22 / Amendments were corrected for the following; Megan Eichorn's name was miss-spelled on page two in paragraph (b). Ed Groff corrected the wording on page (5), corrections made to (4th) sentence (considered) not (cut). Also, on the (11th) sentence, Groff was misspelled and corrected, also the word (proposed) was added in front of (changes). Motion to accept changes to January 10, 2022 minutes:

Motion by: Glenn Null, seconded by Malik Cato.

Motion: Passed unanimously

Current Treasurer's Report: Ed Groff reported to the group; No new activity and the current balance remains \$23, 200.

Motion to accept Treasurer's report by Glenn Null, seconded by: Sharon Beechy **Passed unanimously**.

New Business

- 1. Kyle Richardson on current events Resident of Goshen, IN. Current events regarding Bills & Education at the State House right now. One of the primary "bills" is HB1134. Educators have concerns with this bill. HB1134 calls for increased workloads for Teachers, which is an unfunded mandate, and no other funds are going into the schools to help compensate the Teachers for the increased workloads. There is already a Teacher "shortage" in the State. Many Teachers "nationwide" are having discussions about leaving their professions. Also, the bills call for a "Prohibition on teachers: they are not allowed to engage socially or emotional counseling with students that are LBGTQ, students without parental support will suffer through their health and safety.
- 2. Natural Helper's introduction At the Center for Healing & Hope (Julia Schmidt) Immigrant Resource Coordinator of Goshen, IN, and Lauro A. Zuniga a Natural Helper Coordinator. What they are about: This is a "Nationwide" program in about 12 cities across the United States. It is designed to bridge the gap between residents and the resources available to them. (By identifying training and empowering local immigrants who understand the challenges of moving to a new place and establishing a home in the United States. The goal is about the networking of person-to-person support services, that will help immigrants more actively have access to existing community resources and work with the community and social service organizations. NOTE: AJ wanted to introduce the "Natural Helpers" group so that the CRC could ask them to join a meeting during their "strategic" planning in 2022.
- 3. **Essay Competition** The prompt is on the website, and it is the first link on the CRC webpage. The link includes instructions and information about the; sign-up, essay requirements, prizes, and reception date. The Reception date is Tuesday, April 12th from 6:30 to 7:30 at 111 Jefferson Street, Goshen. Next, the "Winners" will be announced and prizes will be presented.
- 4. Indigenous people's day First brainstorm meeting, there seemed to have five activities that seemed to have pretty strong energy to have for this special day. (1) Proclamation, which would be in the realm of statements given by the Mayor. (2) Land Acknowledgement, which would be a specific sort of statement that acknowledges our place in the history of this land, a way of respecting the land, the people who lived on it before us, our responsibility to it know, and what our hope are for the people who live here in the future.
 (3) Things that could be a part of an event; including a public seminar. (4) We currently have local experts, including those at the Elkhart County Historical Museum. We wanted to include some way to honor the current Indigenous People community members. (5) Information on "Repatriation" efforts that are currently happening. Several Organizations are working at; helping people get the legal documents around if they want to commit their property to an Indigenous community. Providing information for those people who are

interested in that on groups that can help them get that achieved. Ed Groff questioned; who would be convening the next meeting? AJ has plans to convene at the next meeting. AJ plans on sending that email out after this event with the Peace & Justice Group of Middlebury Church of the Brethren. They are sponsoring a free program on February 26 at the library community room at 10:00 am. Their guest speaker is; Mr. Luke Gascho has done extensive research on the Potawatomi tribe. He will share details of where and how the Native Americans lived and thrived, and will answer questions. AJ feels like this would be a good personal education. Take energy from this program and pivot to our next meeting. Ed Groff stated that Luke Gascho's webinar is on YouTube, and it was very informative.

- 6. Sreekala Rajagopalan Thank you letter: Cathie Cripe asked to have the CRC Thank You letters be added to the minutes so that they become part of the minutes for the record. Ed Groff stated his concern about not getting back final documents put on letterhead once the letters have been approved and put on the CRC website. Malik Cato stated the recipient is allowed to give their permission to become a public record. Ed Groff concurred. Michele Fanfair-Steury's thank you letter has not yet been received by Ed Groff after being put on letterhead. Before posting this very personal thank you letters online; the former CRC members will be notified of this process asking for their permission/approval. - 7. Michele Fanfair-Steury Thank you letter: Motion to accept the edit of adding letterhead to the Thank you letter from the CRC.

1. **Director's Report** – Recent mention of getting better at telling your story. There are several ways of doing that. Let's start with a procedural generated, which is a good place to start.

He would like to get at least four bullet points for everything we are doing, and that is; past, purpose, preview, and a way to partner. Thinking about the (*Past*) and how this will fit into the events of the community or the events of the CRC. Ed Groff questioned AJ, asking if he was asking for volunteers for the Events Submitted for First Days? He wanted to allow the newest members to take part in a subcommittee.

Maybe we could show a short documentary and have a panel of respondence? AJ suggested having further conversations.
