MINUTES

Meeting called to order: (7:04 pm)

PRESENT: Malik Cato, Cathie Cripe, Sharon Beechy, AJ Delgadillo, Ed Groff, Glenn Null, E-man Monge

Call to Order & Opening (7:04 pm)

Roll Call and Introduction of Visitors – Completed

Review of the CRC Mission and Principles – Read aloud by the group

Review the agenda (Motion made by Glenn Null) Motion passed unanimously

Review Minutes from March 14, 2022 Motion by Ed Groff, seconded by: Glenn Null,

(Motion to Accept: -Passes Unanimously)

Current Treasurer's – Current balance was carried over from last month, leaving a balance of 22,000 dollars. Motion to accept the Treasurer's Report: Motion by: Sharon Beechy, seconded by: Cathie Cripe.

(Passed Unanimously).

<u>New Business</u> – Nothing new to report.

For the Good of CRC- Community Comment

- a) Glenn Null suggested having bottled waters to hand out at the June, First Friday event in the Art tent area. Glenn also suggested having some of the Art come from the Goshen students, K-12. Perhaps this will also include their parents? This is an excellent way for the CRC to show support, while promoting larger crowds observing the CRC booth.
- b) Cathie Cripe reminded the group how the Goshen Library is a large advocate of displaying Art from surrounding schools of all grades.
- c) AJ added this conversation can have a follow-up conversation via email; this was agreed upon by all of the group.

d) E-man Monge; questioned; if additional ideas arise for First Fridays, for the group; how should they share the information, direct contact, or email? Groups responded to both works. E-man thought it would be a great idea to hand out some CRC promotional items, such as; CRC Stickers with our phone number, and or email contact information. AJ noted that CRC still has T-Shirts and well-designed CRC magnets. E-man would like the CRC to consider a variety of art from different communities, such as; local Nursing Homes, Boys & Girls Club, and Youth Centers.

Reports and Statistics

Director's Report:

- 1. Much of AJ's time has been spent between Juneteenth and Indigenous People's Day. For Juneteenth, we have reached out to our shortlist of Artists, Performers, and Vendors with people we have connections with. We are getting materials ready for marketing out to artists that we don't know yet. Per conversations with a variety of people in our community as an individual; has gotten a lot of people who are surprised and excited to see this picked up in Goshen. That's EXCITING!
 - a) Indigenous People's Day has been very encouraging just working with the number of volunteers and the passion and dedication of the volunteers that have stepped up. We have local experts on Indigenous history, and it has been very encouraging to hear them, and what they have to share. We have expert volunteers stepping up!
 - b) Bringing our vision, a little closer to what's next with the Essay Reception. In our last meeting, we envisioned how we wanted to set up the Court Chambers space. The deadline is a few weeks away, and we have already gotten a few responses.
 - c) Ed Groff asked; if tonight the committee plans to come up with a game plan for the committee that is going to be reading the Essays and making the Awards decision? The judges/readers are; Cathie Cripe, Ed Groff, Steve Bermudez, AJ Delgadillo and Jeremy Stutsman. Ed Groff reminded the group that the Essay information stated there would be five judges, so we still need one volunteer. AJ addressed the other commissioners to see if any of them wanted to participate as judges, Steve Bermudez has agreed to join the group. Megan Eichorn stated she had a student ask her if the essay would be published? Ed Groff reminded the group that the initial form specifically noted that permission was authorized in using it for the public by signing the document. Ed Groff suggested looking at two days after the deadline to allow time to distribute the essays to all the readers, then set a meeting about three-four days after they have been distributed to us. For us to decide, he feels all readers should be in the same room to talk about it. AJ will print out all of the essays and put them in packets for each individual reader. Regarding scoring the essays will need a scale for scoring. Group decided the scoring scale will function as a 1-5 ratio, with 5 being the best. A meeting has been set for March 29. AJ will confirm with Jeremy Stutsman for his attendance.
 - d) Ed Groff: what steps are needed to provide checks to the winners; AJ mentioned it will require a W-9 form filled out, and once this has been turned in, a check will be written.
 - e) Also, Ed Groff asked if the sub-committee has a budget in mind for the Essay reception? Malik Cato indicated that each Principal will have a banner, and the total cost will be around 100 dollars total. Ed Groff suggested changing the wording on two of the CRC Principals because they do not match the other ones, which all start with a verb. He suggests changing the (3rd) principal to read; Cultivating constructive communication and engagement, and (4th) to read; Value honesty, truthfulness, and integrity. To be consistent all of the Principals begin with a verb. Just by definition, a principal needs a verb. If it is just a list of nouns, it is not really a principle. Off the top; Cathie Cripe, Sharon Beechy, and Malik Cato agree with Ed Groff. After minutes of discussion, Glenn Null suggested taking a vote on word changes to the 3rd and 4th Principal. Malik asked if a

vote would be enough right here. Groups responses; (yes). Malik stated he appreciated Glenn Null's apprehensiveness over changing something for a frivolous reason or a no-good reason. He felt it was important to be mindful of that. Malik also thought it was irrefutable, that these two do not start with a verb. Malik feels that consistency is only a boon, I think it would be a way rather than throwing away all the work and consideration that went into forming these, he thinks it would "Honor" that, as we continue to improve the CRC.

Motion by: Cathie Cripe – Wording will be changed on the 3rd Principal to read: Cultivating constructive communication and engagement, also the 4th Principal will read: Value honesty, truthfulness, and integrity. **Motion seconded by**: AJ Delgadillo) **Passed unanimously.**

2. **Council Liaison Report** – Council has been working on redistricting, which is based on the 2020 census report. Council has agreed to create a new (Commission group) for redistricting consisting of; Mayor, CC-T, a Lawyer, and two at-large council people. The five district councilmen will be able to appoint someone to the commission. If the CRC has someone in mind that would serve well on this committee and understands the process, please let Megan know. The Redistricting Committee will be working on the project from April through July 18th, and then it will be presented to City Council for the first time, end date; is completed before the city's budget deadline.

3. Subcommittee Reports

a. **Special Events Subcommittee** (Malik, Cathie, E-man, and Gladys) - Committee discussed possibly getting in touch with more potential vendors. Spreading the word about this event through plans and different types of social media. Also, discussions around the group trying to attend (alike) local events; such as; The Black Expo. A conversation regarding the promotional collateral of required printed material, hand-outs, and flyers. Sharon Hernandez mentioned using the <u>color scheme proposal</u> established for the CRC back in 2017, to help with now and future projects to remain color consistent. Glenn asked; if we planned to use the design with the hand's emblem on the banners? Glenn Null would like to see the emblem changed from the current one; after all, we are making several changes; it's as good of a time as any. Banners are just under 2' x 3'. It was suggested to have only (1) Banner with the current logo, and the other banners can be different, avoiding designer expenses in the future.

Ed Groff has a follow-up from last month, he reached out to Michele Fanfair-Steury and Sreekala Rajagopalan about the "thank you" letters. They are both fine with them being included with the minutes. Also, is that something Sharon Hernandez will do for the CRC? I don't' think we want the (Thank you letters) just posted as themselves with their link? We want them embedded, or attached to the minutes. AJ will put the "thank you" letters at the end of the packets, and Sharon Hernandez will post them online.
