#### **MINUTES**

REGULAR MEETINGS OF THE CITY OF GOSHEN COMMUNITY RELATIONS COMMISSION Monday, June 13, 2022 – 7 p.m.

Meeting called to order: (7:00 pm)

#### **Call to Order & Opening**

Roll Call and introduction of visitor: Completed

Review of the CRC Mission and Principles: Read aloud by the group

Reviewed the agenda – Motion passes unanimously.

Review Minutes from May 9, 2022, & Current Treasurers Report – AJ informed the group that the only expenses he had approved were those related to the Essay Contest. Several items are coming out of the budget from the Juneteenth event, but have not been processed as of tonight's meeting. AJ Delgadillo requested to have a motion for both the; May 9, 2022 minutes and the current Treasurer's Report approved, a Motion made by Glenn Null, and seconded by: Sharon Beechy.

Motion passed unanimously.

#### **Reports and Statistics**

#### 1. Director's Report

- a. For the Juneteenth event, we have four categories of partners registered: Artists, Food Trucks, Artisans, and Information Tables. Set-up for volunteers start is from 9-11, and clean-up crews work from 4-6. Volunteers from the commissioners are Tyra Gichobi and Glenn Null from 4-6 pm.
- b. There is a list of volunteers that are interested in revising the "protocols" for the Essay Contest. Starting the week of June 20<sup>th</sup>, we will reach out to teachers for comments and ideas for the next year's contest.
- c. Also, we will discuss Indigenous People's Day and circle back to the panel discussions that started with Cathie Cripe and Malik to have a panel discussion about ramping up Community conversations, to include **Hispanic Heritage Day**. Last year the CRC was not part of the "Event of the Season", let's not miss this opportunity this year. It would be a good idea to get started on planning the next Juneteenth event.
- d. Please continue to reach out to those people you think would be good volunteer commissioners. Currently, we have seven commissioners, and we have nine seats. Our goal is to have nine commissioners, which makes for a stronger CRC group. We are doing a good job of finding those incidental volunteers. AJ is pleased with the progress of building more bridges to partner with LaCasa.
- e. After discussing the Strategic Planning list and road map for current events and future events it was noted by AJ that the commissioners have done a great job with this. We have not been able to have community conversations held as we had done in 2019, noticeable to our community because it had such a big impact on the community. AJ would like to be brainstorming about what kinds of things we want on our minds when we being our Strategic Planning this year. Also, to confirm what is currently on the road map, see if these things are still a priority, and if have we been able to make progress on them? In August we will start our conversation around Strategic Planning, so please bring your calendars to the July meeting, as we will set some dates for the "retreat". Malik Cato agrees with E-Man that assigning the Strategic Planning categories to specific groups would be helpful. Leaving them all together seems daunting. Glenn Null commented; stating that the item; "Publicize how to start a conflict process". Glenn feels that this topic is needed in our community right NOW! Glenn Null suggested having the CRC Website have an appropriate location for information from local companies providing (mental health, addictions, homelessness, financial assistance), etc. He is very concerned about our City, due to the recent drive-by shooting at Wheatland and Berkey Street in Goshen.

- (Pride Programming) On June's First Fridays, a table discussion was started at the event. Per the discussion, historically the Goshen Pride has not done any programs by themselves. Historically as an unincorporated group, they are transitioning into a not-for-profit group. CRC aims to create a City free of discrimination of any kind. The Pride programming specifically focuses on a great community and falls within the CRC mission. AJ asked for comments from the group.
- AJ suggested that the committee reach out to Adrienne Nesbitt right away. She is already involved with the programs and events. Check with her to see who the CRC can get involved.
- Glenn Null reminded the group of the importance of the CRC's public presence, and how
  it attracts people to conversate. The young teenager asked Glenn Null if the CRC would
  participate in Pride Month?
- E-man shared his conversation with the teenager and invited them to the CRC private meetings that welcome the residents to share their comments and ideas. Also explained the CRC mission and how we are here to support various communities.
- E-man explains there are so many things to celebrate, we need to find the people in the community that could spearhead the events, and the CRC join their efforts.
- It was agreed that AJ will be reaching out to Adrienne Nesbitt for Pride month in 2023, to see where the CRC can get involved. AJ gave a shout-out to Sharon Beechy for her drafting of the proclamations and other written materials for the CRC events.
- 2. Council Liaison Report (Megan Eichorn) Absent
- 3. Subcommittee Reports (AJ) Nothing new to report
  - a. Indigenous People's Day (Ed, Cathie, Sharon) This group has a ton of volunteers. Our program is almost finalized. Our next step is to have a meeting at the Goshen Theater. We will have an educational table with activities, books, and portraits. And then we will have a small seminar with local experts in Indigenous People's history. Presentations will be from the Citizens band of Potawatomi and the Miami Nations. This event is in October

#### **New Business**

#### For the Good of CRC – Community Comment

Are there any comments from the Community from the Juneteenth event? Sharon Beechy responded; A church friend asked her about the Juneteenth event because she had not seen any publicity regarding the event. AJ's response – there was a mention of the event in the recently mailed Maple City Now mailer received by residents on June 25<sup>th</sup>, just before the event. Also, a "press release" was on Tuesday, June 21, 2022, from the Goshen News and the Elkhart Truth. The City of Goshen Facebook page included an announcement of the Juneteenth event as well. AJ thought there was an ad coming with more announcements, and if not, we should do it, there is money in the budget for it.

Malik Cato made a motion to add the (Pride Month involvement) discussion to the agenda, seconded by: E-Man. <u>Motion</u> passes unanimously

#### Announcements by CRC members, closing comments, and reflections on the meeting:

Glenn Null suggested having a Year Calendar for everyone so that we have a good idea of what we are planning in the future. For outdoor events like the (First Fridays), he believes the CRC should have a 10 x 10 pop-up tent to keep the staff out of the elements, with the CRC logo spelled out. It makes the public notice the logo on the pop-up as it stands out. This way they purposely enter the tent. AJ agreed that certain things are needed for staff while working our events. AJ suggested starting a subcommittee to work on the list of items to purchase for ongoing events, and upcoming events. Glenn Null, Malik Cato, and E-Man have volunteered to be on this committee.

In wake of the recent shooting, AJ is asking for comments on solutions to help with what not to do, and what you can do with our website that includes misinformation on breaking news or incomplete information to keep it from turning racial or harmful?

Tyra Gogichobi commented that she is I think it went well. She enjoyed hearing about Juneteenth and being part of the event. Thank you all for having me.
