APPROVAL OF MINUTES

A motion was made by Commissioner Weddell and seconded by Commissioner Brenneman to approve the minutes of the March 12, 2024 regular meeting.

<u>Resolution 08-2024</u> – Approve Funding for and Recommend Award of Bid and Execution of a Contract for the Steury Avenue and Lincoln Avenue Reconstruction and Drainage Improvements Project

Becky Hutsell, Redevelopment Director, three bids were received ranging from 9 to 12 million. The breakdown of the bids is in the memo in the packet. After a full review, recommending to proceed with Niblock Excavating with a base bid of 8,829,875.50 with bid alternate at \$267,882.50 for a bid total of 9,087,758.00. Ms. Hutsell stated the bid has the 1.25% contingency included.

Discussion and questions between commission members and staff.

Councilor Matt Schrock asked Ms. Hutsell questions about the project and stated that the area is excited to have this project moving forward.

A motion was made by Commissioner Weddell and seconded by Commissioner Brenneman to approve Resolution 08-2024.

<u>Approve a Request for Negotiation of an Agreement with the Goshen Chamber for the Building at 113 West Jefferson Street</u>

Becky Hutsell, Redevelopment Director, in place of doing a resolution, we are asking for permission to negotiate an agreement for the building at 113 West Jefferson Street. Currently evaluating space needs to see if the existing Chamber building is suitable for any city departments. Nick Kieffer, Chamber President, is here to answer any questions, but the commission did not have any.

Questions and discussion between staff and commission members.

If permission is granted, a resolution approving the agreement will be brought before the Commission for final approval.

A motion was made by Commissioner Weddell and seconded by Commissioner Graber to approve the motion authorizing permission to negotiate an agreement for the building at 113 West Jefferson Street.

The motion was adopted unanimously.

MONTHLY REDEVELOPMENT STAFF REPORT

Becky Hutsell, Redevelopment Director, told the commission that she anticipates soon having updated renderings for the Ariel Cycleworks project and development agreement with Kosene to bring to the commission in May.

Ms. Hutsell commented that in mid-March the Indiana Finance Authority Residential Loan Program became available with a due date of April 1, 2024. Worked with Cherry Creek and turned the application around in six days. Awards of the program will be made in June.
