VIII. Approval of Superintendent and Director Reports

IX. New Business

1.) Master Plan Update

Steve Ruby, consultant from the Troyer Group, updated the Board on the preliminary survey results that included percentages of park visitation, common activities the public likes to do at the parks, walkability of the trails and trail use. Ruby also informed the Board of past and future public events attended to gain feedback from the community as well survey results that included potential interested donors.

2.) Tree Canopy Goal

Aaron Kingsley, Parks Forester, presented the Board with a proposal to adopt an Urban Tree Canopy Goal of 45% canopy cover by 2045. Kingsley explained his strategy and importance of achieving this canopy goal such as number of trees needed, the importance of maintaining the trees, how the tree canopy goal will benefit our ecosystem, health, financial benefits, how and who would need education about the tree canopy goal and how to participate in it. Financial support for the tree canopy goal was discussed. Heyde explained supporting and approving the canopy goal includes financial support as outlined in the proposal. Kingsley asked the Board for approval and support of this proposal going forward to the City. On a motion by Wellington, seconded by Swartley, ayes carried.

3.) Recreation Service Agreements

Stephens presented the Board with service agreements for Emilia Dupin, Adult Coed Volleyball Referee and Pamela Sanchez, Zumba Instructor. Stephens requested permission to enter into and execute these agreements as presented. On a motion by Wellington, seconded by Yoder, ayes carried.

4.) Maintenance Service Agreements

Yoder presented the Board with service agreements from Abonmarche to complete surveys at Dykstra Park (1500 E. Lincoln) for plans to construct a new pavilion, 9th Street (117 & 119 S. 9th Street) for a proposed dog park and the Hay Park (1414 W Plymouth Avenue) for the preparations for the inclusive playground.
